Madison County Drug Court



At the Partnership's September meeting Deputy Chief Michael Wilkinson and officer Todd Hansel presented on Madison County's Drug Court. It was established in 1996 and created due to the elevated occurrences of nonviolent drug related felonies in Madison County. The program provides support and rehabilitation through comprehensive substance use and mental health treatment and educational programs all while being judicially monitored.

*Since inception the drug court has treated I500 plus clients *75I individuals have successfully completed the program *98%of the graduates have graduated high school or earned a GED *I00% of graduates obtained employment while in the program *85% of the clients participate in Medically Assisted Treatment.


